#### <u>Financials</u>

The June, July, and August 2023 Unaudited Financial Statements were discussed and a motion to approve them subject to audit was made by Mike Metcalf and seconded by Joel Cope. The motion was approved unanimously on a voice vote.

### New bank account Brownfield Revolving Loan Fund

David Snedeker explained the need for a separate fund account for EPA Brownfield Revolving Loan Fund monies award to NVDA. EPA prefers to track the mix of loan funds by loans and sub-grants, so a separate account makes this easier.

A motion to approve the opening of a new account for the Brownfield Revolving Loan Fund was made by Joel Cope and seconded by Gina Vigneault. The motion was approved on a voice vote. NVDA staff will work to utilize a local bank for this new account.

#### ST. Johnsbury - NVDA - Developer MOU

David Snedeker brought the possibility of being interim property owner for a new proposed housing development at 545 Concord Avenue in Saint Johnsbury, similar to what was done in Lyndonville years ago. A Phase One site assessment has been completed; awaiting Phase Two assessment to be initiated. If/when moving forward pending the results of the Phase Two assessment, the Town of Saint Johnsbury along with the developer will come before the board and present the MOU for consideration.
