



## **Biomedical/Biotechnical (Life Sciences) Industry Cluster**

Identified as one of the "opportunity" clusters in the Northeast Kingdom, the biomedical /biotechnical industry cluster is made up of biomedical oriented manufacturing sectors, equipment and supplies wholesalers, health and personal care stores, and ambulatory health care services. With a 2009 employment base of 1,600 workers, this industry cluster clearly research as important part of the

industry cluster clearly represents an important part of the Northeast Kingdom economy. An additional 600 workers, classified as either non-employers or self-employed, are engaged in the broader industry. Combined, the 2009 employment base of the biomedical and biotechnical industry cluster is 2,200 workers. With respect to its export orientation, the regional biomedical/biotechnical cluster services markets beyond the Northeast Kingdom.



The addition of Numia Medical Technologies, LLC in 2010 has strengthened this industry cluster in the region.
