Brian McWalters from Vermont Emergency Management did a presentation on the Hazard Mitigation Grants that are currently available to communities.

There was discussion of Quorum based on recent changes to the Quorum requirement at REMC Meetings by the Legislature. If there are five voting members from the REMC attending the meeting then it qualifies as a Quorum, through December 31, 2023. After December 31, 2023, there must be a minimum of 20% of voting members attending the meeting to qualify as a Quorum. For Orleans-Essex REMC that number would be twelve voting members. Sandra Leonard made the motion to have the quorum number be 12 as of January 1, 2024. The motion was seconded by Gina Lyon and passed.

Sid Pollock, the Regional Coordinator for Vermont Emergency Management was unable to attend but did send an email with a Vermont Emergency Management Update and Report.
